**CARE AND OWNERSHIP:** By purchasing this puppy, BUYER agrees to provide excellent care of this puppy and will take necessary measures to ensure its health, safety, and lifelong care. If for any reason BUYER is no longer able to care for this Puppy, BUYER will contact SELLER to help arrange placement of the dog in another acceptable home or allow SELLER to purchase the dog back for 50% of the purchase price listed on this contract.

**HEALTH GUARANTEE:**

***For this Health Guarantee to be active, BUYER, MUST take their new puppy to a licensed, reputable, veterinarian within 48 hours of receiving the puppy, for a health/physical exam. Failure to follow through with this will void the Health Guarantee.***

**PET/COMPANION:** your dog is purebred but is being sold for pet/companion purpose only and is not considered for breeding or show quality. It is registerable (at buyer's expense) with the ASDR as LIMITED registration. It is **required** that your dog be spayed/neutered at the recommended age by your vet. Please help us keep to the breed standards and prevent overpopulation by keeping this dog for pet/companion purposes only.

**FULL BREEDING RIGHTS:** Your dog is purebred and can be part of your responsible breeding program. Pedigree is given at time of purchase. Dog is fully registerable with ASDR (at buyer's expense). Seller makes no guarantees concerning size, breeding ability or whelping.

Breeder guarantees that this dog is in good health and has been vaccinated according to his/her health record. Buyer agrees to complete the 2 remaining puppy vaccinations at approximately 12 and 16 weeks, and a rabies vaccine by 5 months. If your dog is found to be unhealthy by your veterinarian at the initial 48 hour mandatory veterinarian health check, and the cause of which is clearly the seller's fault, the dog may, upon a signed written diagnosis from said veterinarian, be returned for refund of the purchase price within 72 hours of the purchase. The seller assumes absolutely no responsibility for fees associated with caring for the puppy, veterinarian fees, shipping or traveling to meet seller. Additionally, we guarantee that your puppy is free from **life-threatening genetic defects** for their first year of life. If a problem arises within the puppy's first year of life, seller is to be notified immediately so that we can discuss the prognosis with our vet and have the opportunity to get a confirmation of that diagnosis from our vet, at no charge to you. Failure to send a written veterinarian report of diagnosis to the seller within 24 hours of the diagnosis voids this Health Guarantee. If it is found by our vet that they agree with the buyer's veterinarian about the diagnosis and prognosis of the puppy, seller will allow buyer to choose a puppy from the next available litter equal to the price of the initial puppy purchased. We do not refund any money after 72 hours of the initial purchase. In the event Seller stops breeding Australian Shepherds this contract will no longer be valid.

**Stress Related Illness**

Buyer also understands Coccidia and/or Giardia, kennel cough, pneumonia, hypoglycemia, and other **stress related** illnesses may occur in their puppy from the stress of the move or flight to their home, and buyer is solely responsible for any vet bills incurred as a result. Buyer agrees to provide food, water and adequate care while traveling with their pup.

**Parvo**

Buyer understands they should not take their puppy anywhere they could come in contact with, or where unvaccinated dogs may have been, **until 2 weeks after** his/her 4 month booster is completed, as this could transmit Parvo to their puppy.

The BUYER(S) and Stonehill Aussies, SELLER, have read and understand this agreement and fully agree to all parts and portions thereof and consider it to be a binding agreement between both parties.
